**AGREEMENT BETWEEN PARENTS (CUSTOMERS)
AND RENAISSANCE HOLDING Ltd.
ON LEGAL SERVICES AGENCY**

This is a contract between RENAISSANCE HOLDING Ltd., registration number 122391, based in Kiev City 04107, 2 / 6 Otto Shmidta Street, Ukraine (referred to as “AGENCY”)

number _____ (referred to as “PARENTS”),
residing at _____ (main residence).

The contract contains all the essential information about the agency, about all the organizational steps, the costs of the services connected with fertilization, egg donation, and the terms of payments.

The RENAISSANCE HOLDING Ltd. herein agrees to any services (referred to as “SERVICES”) described in the article concerning the organizational part of the **SUCCESS Package**. This document confirms that during the IVF procedure the AGENCY is to bear all the necessary expenses concerning artificial insemination, the cost of egg donation and compensation for the donor.

According to this agreement the biological PARENTS agree to pay the amount of money which is specified in the article concerning the cost of the **SUCCESS Package**.

Organizational part

1. During the first visit (1 to 2 days) the patients are met at the airport by the representatives of RENAISSANCE HOLDING Ltd.
2. Biological parents are provided with a comfortable accommodation during the entire stay.
3. Food supply during the first visit is included in the cost of the package.
4. The first visit to the clinic implies medical consultation by the supervising physician.
5. Service of an interpreter for the entire period of the program.

6. During the second visit (5 to 10 days) the pick-up of the biological father's sperm, fertilization of donor's eggs and embryos (blastocysts) transfer into the uterine cavity (on the 5th day after fertilization) are performed.
7. Accommodation and food supply are the same as during the first visit.

Medical part

First of all we need to know the genetic father's blood group.

1. The couple selects the desirable donor from the egg donor database provided by Biotexcom clinic).

Our requirements for the donors are:

- a) age from 18 to 25;
 - b) perfect physical health;
 - c) perfect mental health;
 - d) absence of genetic diseases in the donor and her family (siblings, parents, uncles, aunts, grandparents).
 - e) at least one child of her own that means proven fertility.
3. The couple will need to come to Ukraine at least twice:

The first visit (1 to 2 days) includes medical examination in Biotexcom clinic and organizational meeting. RENAISSANCE HOLDING Ltd. provides information on the program, organizational and medical parts in Biotexcom clinic and terms of the contract.

During the second visit (5 to 10 days) the sperm pick-up, fertilization of donor's eggs and embryo transfer on the 5th day after fertilization are performed.

In case of five unsuccessful attempts you will get your money back!

The cost of the SUCCESS Package

Egg donation package "SUCCESS" costs €9900.

This package is ideal for clients who wish to avoid risk. I.e. the package implies five attempts. In the event that all attempts fail, the clients get their money back.

The medical part of the program is paid according to the price list in the clinic BioTexCom by cash or through the POS terminal.

The rest of the payment is made to Renaissance Holding Ltd by cash or to account.

A positive result of pregnancy is a pregnancy that reaches the period of 12 weeks. Due to the terms of the agreement, if the patient has a miscarriage before 12 weeks of pregnancy, we guarantee the resumption of attempts.

Our obligations are considered to be fulfilled when the pregnancy reaches 12 weeks.

If that contract is terminated by the client before the beginning of any procedures, 1000 euro is kept back from the first payment.

If that contract is terminated by the client during/beginning of the donor stimulation or during/beginning of stimulation for the client's eggs, 50% is kept back from the first payment, made by client.

If that contract is terminated by the client if the donor is on birth control pills, getting ready for the program, 35% is kept back from the first payment, made by client.

Client has to follow all doctors' instructions according to the treatment plan, not hasten the process and avoid self-treatment, stick to the stimulation protocol and dates for the ultrasounds and medication. In case of self-treatment and/or unauthorized treatment/stimulation with hormonal medications the client is charged by penalty at the rate of 30% of the paid amount. The ultrasounds have to be sent to the manager's email address the day it is appointed, if the ultrasound is not sent on the proper date, the program is suspended and the client's line position is moved to the last (for clients on ovarian stimulation). Violating doctor's instructions and protocol by the client may lead to contract termination without possible refund.

Periods between attempts are determined by the doctor only.

If the client will need a reduction according to our doctor's instruction, the client must perform the reduction in our clinic no less than on 8 weeks of pregnancy. In case the client is not fulfilling this condition, clinic stops the contract and takes no responsibility for the health of the client and all consequences. The price of reduction is included into the price of the package.
